REQUEST FOR PROPOSALS (RFP)
FOR
FACILITY-BASED CRISIS SERVICES FOR ADULTS
IN
THE SANDHILLS CENTER CATCHMENT AREA**

Sandhills Center is currently requesting proposals from for-profit and not-for-profit providers to provide Medicaid and State funded Facility-based Crisis Services for adult members residing in Anson, Guilford, Harnett, Hoke, Lee, Montgomery, Moore, Randolph and Richmond counties. The facility, which requires a .5000 license from the Division of Health Service Regulation, must be located within the Sandhills Center catchment area. The Facility-based Crisis provider must be able to serve involuntary commitment patients, and staff must be able to perform routine medical clearance reviews of members presenting at the facility. The individuals to be served are members with a primary mental health diagnosis and may have a co-occurring substance abuse diagnosis.

UCR and non-URC funding will be available for the provider(s) selected through this RFP process. Non-UCR funding will be available for startup costs for those provider(s) selected, as negotiated.
